 - Special Areas Rec Board Meeting was held in Empress on Friday Oct 14, 2022. Representatives from the various groups lead tours of their facilities and informed the Rec Board members of activities and functions in their facilities.
 - CAO Peers was involved in a virtual meeting with all the regions CAO's and the Executive Director of Palliser Regional Municipal Services where a report on the funding of PRMS was tabled. The report s final recommendation proposed increases to membership fee's; The proposal would increase Palliser Regional Planning Fee's (Currently about \$225/month to \$416/month over a 5year time frame)
 - Art Instalment update is that no response has been received as yet from the Blackfoot Chief.

5.2 CAO Report by Gary Peers

- IT upgrades, progressing, need one good day with staff to keep it moving.
- Future power back-up upgrade updates, Estimates for Office only are in the \$14,000 range, a small genset for the old shop would be in the \$2500 range plus a disconnect switch about another \$500
- Public Works Report; Fall work close to completion, equipment parked, putting away for winter. Helped with water issues as well as some sewer help to Dallas at RV park. Garbage as usual equipment repairs 90% complete, Bobcat to Neilson Mechanical for major hose repair. Assist on water break repairs this week.
- Splash Park Update, Inspected with Martin Jarvis as he explained system, I determined the breakage was likely due to human error so cancelled the expensive repairs. We drained, added a/f in lines as needed, ready for winter & backfilled hole. I recorded a movie of the procedure for files.
- Tower roof assessments and estimates for repair; Pricing out costs of a 85 foot skyboom for a week as well as delivery & return charges, about \$6-7000; Spray foam for filling cracks and asphalt crack filler would be under \$500; Finding manpower for about 4 days work about \$1600. Total Estimate \$8100-\$9100
- Financial Report as at Sept 30, 2022 (not available) but still expect over budget in utilities and most likely salaries due to compliance costs for the short term.
