7. Old Business: a) Dog Bylaw

At the November 15, 2023 Regular Council Meeting, Council passed second and third reading of the Dog Bylaw 2023-02. However, administration is unable to find first reading for this bylaw. Additionally, there are concerns with the body of the bylaw. As first reading does not appear to have been done and the bylaw has not been signed and sealed, the "new" bylaw 2023-02 is NOT in effect and the previous bylaw 2018-05 remains in effect. In the Council package you will find a history of motions related to the dog bylaw as well as the bylaw that was presented to Council in November.

b) November 21, 2023 email from Marigold Library System regarding Freedom to Read Week Proclamation

As per the email in the agenda package, the Town of Oyen is willing to provide back up coverage at the same rates and mileage, and a similar work schedule as our operator.

d) December 4, 2023 letter from the Special Areas Board regarding the 2023 Recreation Mill Rate Grant

Each year the Special Areas Board provides a Recreation grant to the Village of Empress. This year's grant is in the amount of \$37,942.70. Administration has looked to see how this grant has been allocated in the past. Historically, \$10,000 has gone to the Empress Bindloss Agricultural Society, \$1000 to the Empress Library, and \$1000 to the Empress Fire Department. If Council has additional information on how this grant has been allocated in the past, they are asked to bring it to our attention. To help with tracking and accountability, administration requests a motion regarding this grant allocation.

(that the Special Areas Board 2023 Recreation Mill Rate Grant in the amount of \$37,942.70 be allocated as follows:

\$10,000 to the Empress Bindloss Agricultural Society

\$ 1,000 to the Empress Library

\$ 1,000 to the Empress Fire Department

e) Christmas Hours

According to Village Policy 12-07 "Paid Holidays" employees are entitled to 5 days off, in a row and inclusive of weekend days, for Christmas.
